AN ORDINANCE

Amending the 2015 General Fund Budget as a result of an \$8,000 donation from Helen Steedle in honor of Captain Gail Struss, the funds are to provide equipment to the Crisis Negotiation Team and the Police K-9 Unit.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2015 General Fund in the amount of \$8,000.00 reflecting receipt of monies from Helen Steedle to provide necessary equipment to the Crisis Negotiation Team and fund needed for the Police K-9.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Police Department, various programs as follows:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
