AN ORDINANCE

Amending the 2015 General Fund Budget as a result of a \$5,012 grant from the Lehigh County Mental Health/Intellectual Disabilities Drug & Alcohol/Health Choices to for crises intervention training.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2015 General Fund in the amount of \$5,012.00 reflecting receipt of monies from Lehigh County Mental Health/Intellectual Disabilities Drug & Alcohol/Health Choices for participation in Lehigh County's CIT Training.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Police Department, Training program as follows:
