

ORDINANCE NO. 15244

AN ORDINANCE

Amending the 2015 Capital Project Fund Budget to provide for a supplemental appropriation of Seven Hundred Nine Dollars (\$709) from proceeds raised at an October 24, 2015 fundraiser for the design and construction of a skate park at Jordan Park.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the Capital Project Fund in the amount of Seven Hundred Nine Dollars (\$709.00).

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Project Fund in the following manner:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.
