AN ORDINANCE

Amending the 2016 General Fund Budget to provide for a supplemental appropriation of \$1,575 as a result of a donation for the L.I.F.E. (Living with Integrity for Future Excellence Program) an Allentown Youth Initiative.

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2016 General Fund in the amount of One Thousand Five Hundred and Seventy Five Dollars (\$1,575.00) reflecting receipt of monies for the L.I.F.E., an Allentown Youth Initiative

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund in the amount of One Thousand Five Hundred Seventy Five Dollars (\$1,575.00).
