AN ORDINANCE

Amending the 2016 General Fund Budget to provide for a supplemental appropriation of \$10,000 as a result a donation from Helen Steedle to be used towards the purchase of Tasers for the Police Department

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2016 General Fund in the amount of Ten Thousand Dollars (\$10,000.00) reflecting receipt of a donation from Helen Steedle for the purchase of Tasers for the Police Department.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Grant Fund in the amount of Ten Thousand Dollars (\$10,000.00).
