AN ORDINANCE

Amending the 2016 General Fund to provide for a supplemental appropriation in the amount of Six Hundred Fifty (\$650) Dollars as a result of a donation from the Allentown Mountainville Lions Club to be used toward the purchase of a protective vest for a new officer in the Police Department.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2016 General Fund in the amount of Six Hundred Fifty Dollars (\$650.00) reflecting receipt of a donation for the purchase of a protective vest for the Police Department.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund in the amount of Six Hundred Fifty Dollars (\$650.00).
