AN ORDINANCE

Amending the 2008 General Fund Budget to provide for a supplemental appropriation of One Thousand Five Hundred (\$1,500) Dollars to provide for the receipt of a grant from the Keystone Active Zone. This grant is for the support of the City's playground program.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a One Thousand Five Hundred (\$1,500) Dollar increase to the unappropriated balance of the General Fund.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund in the following manner:
