AN ORDINANCE

Amending the 2011 General Fund Budget to provide for a supplemental appropriation of Eight Hundred Forty-Eight Dollars and Ninety Cents (\$848.90). This is a donation from Mountainville 30 Crime Watch to the Police Department equipment program.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2011 General Fund in the amount of Eight Hundred Forty-Eight Dollars and Ninety Cents (\$848.90) reflecting receipt of monies from Mountainville 30 Crime Watch to the Police Department equipment program to purchase a Taser.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Police Department, Equipment program as follows:
