AN ORDINANCE

Amending the 2012 General Fund Budget to provide for a supplemental appropriation of Nine Hundred (\$900) Dollars as a result of a donation from Tilted Kilt Pub & Eatery to the Police Department K-9 program to provide necessary equipment.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2012 General Fund in the amount of Nine Hundred (\$900) reflecting receipt of monies from Tilted Kilt Pub & Eatery to the Police Department K-9 program to provide necessary equipment.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Police Department, K-9 program as follows:
