AN ORDINANCE

Amending the 2012 General Fund Budget to provide for a supplemental appropriation of Eight Hundred Fifty Dollars (\$850). This is a donation from Elizabeth McCafferty to the Police Department for police equipment.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2011 General Fund in the amount of Eight Hundred Fifty Dollars (\$850), reflecting receipt of monies from Elizabeth McCafferty to the Police Department for police equipment.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Police Department, Equipment as follows:
