AN ORDINANCE

Amending the 2011 General Fund Budget to provide for a supplemental appropriation of Twenty-Five Thousand (\$25,000) Dollars. This is a donation from Air Products to the Police Department technology/equipment program to provide for technology upgrades.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2011 General Fund in the amount of Twenty-Five Thousand (\$25,000) Dollars reflecting receipt of monies from Air Products to the Police Department equipment program to provide for technology upgrades.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Police Department, Equipment program as follows:
