

Allentown's Population and Housing

A Comparison of the 2010 and 2000 Censuses

This report is the first in a series of Census analysis for the City. The immediate report is a comparison of the 2000 to 2010 Decennial Censuses, providing a snapshot of the City’s demography and housing for the City as a whole by City area and census tract. Generally it follows a format for a similar study comparing the 2000 and 1990 censuses entitled *Allentown 2000*. The report includes tables and text and a 2010 census tract map. The Census Bureau modified three census tract boundaries. As the map illustrates, comparability is possible by combining tracts in the following manner:

Identifying the changes is facilitated on the map through different colored boundaries.

Terms

To better understand the tables the following definitions are provided.

Family—A family consists of a householder and one or more other people living in the same household who are related to the householder by birth, marriage, or adoption. All people in a household who are related to the householder are regarded as members of his or her family.

Household-A household includes all the people who occupy a housing unit. (People not living in households are classified as living in group quarters.) A housing unit is a house, an apartment, a mobile home, a group of rooms, or a single room that is occupied (or if vacant, is intended for occupancy) as separate living quarters.

Housing Units-A housing unit is a living quarters in which the occupant or occupants live separately from any other individuals in the building and have direct access to their living quarters from outside the building or through a common hall. Housing units are usually houses, apartments, mobile homes, groups of rooms, or single rooms that are occupied as separate living quarters. They are residences for single individuals, groups of individuals, or families who live together. A single individual or a group living in a housing unit is defined to be a household. Additional details about housing for the elderly population and group homes are provided in the section “Housing for the Older Population.”

Hispanic or Latino Origin-The terms “Hispanic,” “Latino,” and “Spanish” are used interchangeably.


Race-The classifications are self- described emanating from census forms. The Office of Management and Budget requires five minimum categories (White, Black or African American, American Indian, or Alaska Native, Asian, and Native Hawaiian or Other Pacific Islander) for race. With the Office’s approval a sixth category, “Some Other Race,” has been added and is described below.

Some Other Race—Includes all other responses not included in the “White,” “Black or African American,” “American Indian or Alaska Native,” “Asian,” and “Native Hawaiian or Other Pacific Islander” race categories described above. Respondents reporting entries such as multiracial, mixed, interracial, or a Hispanic, Latino, or Spanish group (for example, Mexican, Puerto Rican, Cuban, or Spanish) in response to the race question are included in this category.

Two or More Races—People may choose to provide two or more races either by checking two or more race response check boxes, by providing multiple responses, or by some combination of check boxes and other responses.



2010 Census Tract Boundary Map Allentown PA







Summary

Table A: Total Population by Sex and Age

City of Allentown

The City's population grew by more than 10% between 2000 and 2010

- Slightly more than half (51.8 %) of Allentown's population is female.
- During the 2010-2000 census period, the population grew younger, having more than 26% of its population under the age of 18, an increase of 1.4%.
- Correspondingly, the population over 64 declined by 3.2% to only 11.9% of the City's total.

City Area

- Center City and Mid City areas grew by more than 14% and exceeded the city growth rate. Center city had the highest youth percentage, comprising more than 32% of the area's population, an increase 1.5% over 2000.
- Center City had the smallest percentage of 64+ persons, nearly half the city rate (6.6% vs. 11.9%)
- The highest elderly area rate is the West End at 19.0%, which also had the lowest rate of youth at 15.2%.

Census Tracts

- Census Tract 23.01 grew the greatest, at more than 25% due to new residential construction.
- Supporting Center City's growth rate, are Census Tracts 97 (former tract 11 and 13) and 17 growing by more than 21% and 21.6%, and 16, growing at more than 17%.
- The under 18 population composed more than 30% in 10 tracts of the population compared to the city's rate of 26.2%.

Figure 1: Change in Population 2010-2000




Figure 2: Age Distribution 2010 - 2000



Tables B and C: Population by Race and Hispanic Culture

City of Allentown

- Allentown’s diversity has grown between the censuses. Racially it is less white, and more minority. Culturally, Allentown’s Hispanic presence grew substantially during the period by more than 26,000 persons or 93.6%, composing 42.8% of the City’s population.
- In absolute terms, all racial minorities grew, with Blacks growing by 6442 persons, or 77%. On a percentage basis all groups grew with the exception of Asians, which declined by .1%, increasing in absolute terms by 98 persons.

City Area

- Center City was home the largest number of Blacks (2440), and Eskimo-American Indian (490) as well as almost half of the City’s Hispanic population (23,560 of a total of 50,461).
- South Allentown had the greatest number of Asian, Native Hawaiian, and Pacific Islanders (801 of 2597).
- The highest percentage White representation was in the West End at 84.2%.

Tracts

- Hispanics constituted more than 2/3rds of Tracts 5 ,7, 8, 10, 16 and 17.
- Blacks were almost 20% of Tract 5.
- Asians etc. represented 6.7% of Tract 23.01 up from 3.3% in 2000.




TABLE D: Households

City of Allentown

- The number of households grew slightly by 1.9%, less than the city growth between the censuses. Family households grew by more (6.2%) than the overall household rate constituting 62.3% of all households an increase of 2.5% over 2000.
- Both persons per household and family grew, households by .22 and families by .29 persons respectively.

City Area

- Households increased the greatest in the West End (8.3%), and decreased the greatest in Mid City (-2.2%). The highest percentage of family households was in Center City (66.7%).

Census Tracts

- The greatest percentage of additional households was Census Tract 23.01 (26.7%) followed by Census Tract 97 (14.2%).
- Tract 97 also had the greatest increase in family households (27.5%) followed by Tract 23.01 (20.4%).
- Tracts 7 and 8 have the largest household sizes of 3.45 and 3.50 persons.
- In 2010 there were 8 tracts with an average household size of 3 persons or more, compared to 2000 with only 3.

Figure 5: Percent of Family Households



City of Allentown

- The city's housing stock grew by 961 units or 2.1%, while its vacancy rate increased slightly by about .3% to 8.8%.
- The owner occupancy rate declined to 48.6% a difference of 4.6% from 2000's level.
- The number of persons in group quarters grew increase by 1.5% to 5070.

City Area

- The West End experienced the greatest absolute and percentage growth in housing units, growing by 10.6% or 741 units, while Mid City showed the greatest absolute decline with a modest 36 units or -.5%.
- Owner occupancy was highest in the West end at 64.3% and the lowest in Center City of 33.4%. Both areas showed declines of 4% and 8.9% respectively.
- In Center City vacancy rates declined by almost 2%, while they increased by 2% in the West End.
- In Mid City persons living in group quarters increased by about 22%, to 326 persons. The greatest number of persons living in group quarters is in the West End amounting to 2850 an increase of 6.5%.

Census Tracts

- Tract 23.01 had the greatest housing unit rate and number increase totaling 745, an increase of 28%. The second highest number of new additional units was Tract 15.02 with 151. Tract 5 increased by 6.8% amounting to 54 units.
- Census Tracts 97 (former Tracts 11 and 13) and 9 showed vacancies decline by 5.8%. Vacancy rates increased the greatest in Census Tracts 23.01 and 96 (former Tracts 1 and 2) by 5.7% and 5% respectively.
- Owner occupancy declined in every census tract, several by double digits. The greatest declines were in Tracts 7 and 9 with reductions of 13.7 and 12.3 percent.
- Group quarters residents were the highest in tracts 22.02 with 2338 most of which includes college students, and Tract 12 with 1083 including the Lehigh County Prison which increasing by only .2% from its 2000 level.

Figure 6 Vacancy Rate 2010 - 2000




Figure 7: Percent Owner Occupied 2010 - 2000


