## tip 411

Report crimes anonymously help clean up the streets of Allentown...

Anyone with a cell phone can send an anonymous tip to Allentown Police by texting the word TIPAPD, YOUTHAPD or VICEAPD and the tip information to 847411 (tip411). Anonymous web tips can also be submitted right from the city's website.

It is 100% anonymous. The technology removes all identifying information before the police department sees it, so there's no way to identify the sender.

Users simply enter the number 847411 in the New Text Message line of their cell phone; then type in TIPAPD in the text box; use one space without punctuation and then type their tip and hit the SEND button.
