# 3. Energy Efficiency and Renewable Energy

According to Christopher Nafe (former sustainability director for City of Harrisburg, currently at PA Dept of Energy) the COA was approved to get one of these managers
- This person will need the COA asset list in order to best address the potential energy saving projects. It has been bounced around a lot between different city departments.
- EAC will help facilitate the delivery of this list to the manger when announced

- Focus on creating a centralized database either within the city organization or separate to store and regulate the official EAC materials.

- Will work in tandem with the sustainability coordinator to develop and track projects, ensuring the public and EAC members have transparent access to the progress on our initiatives. Keeping us efficient and accountable. ETAs.
- Should create a folder to keep track of our goals and progress through the year

### 6. Local Climate Action Plan (LCAP)
