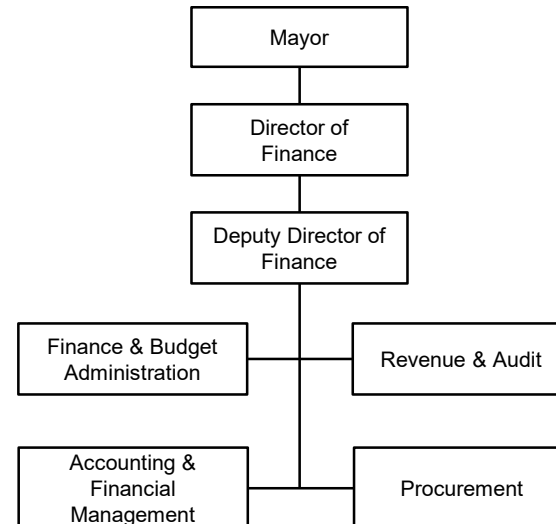
Values
