Mission

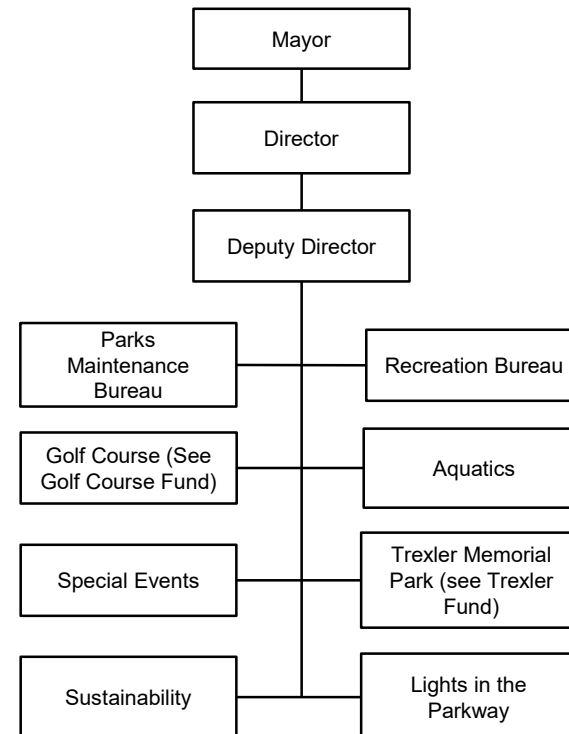
