#### **STATEMENT**

The purpose of the City of Allentown's Emergency Operations Plan is to establish a comprehensive emergency management program that ensures a coordinated, efficient, and effective response to emergencies. The plan aims to preserve life, minimize property damage, provide critical assistance during emergencies, and support recovery efforts to restore the community to normal conditions.

#### **PLAN**

This plan, along with all references, appendices, and annexes, defines the roles, responsibilities, locations, and procedures necessary to mitigate, prepare for, respond to, and recover from the effects of natural and technological disasters.

This plan will work if each director and each bureau head require every employee under their jurisdiction to be assigned to the snow emergency workforce to:

- BE AWARE OF THE SHIFT IN CHAIN OF COMMAND DURING AN EMERGENCY
- BECOME FAMILIAR WITH THEIR ASSIGNED DUTIES
- COOPERATE FULLY

#### **DECLARATION OF EMERGENCY - PERSONNEL**

1. Weather Reporting Service

- 2. Weather reports are emailed by the Weather Service to the City Snow Control Center 24 hours per day. The report is then emailed to the following City offices.
  - A. Director of Public Works
  - B. Mayor's Office
  - C. Emergency Management Coordinator
  - D. Bureau of Parks
  - E. City Garage

Weather reports are emailed to various PW staff by the weather service during Saturdays, Sundays and holidays. These reports are immediately relayed to the Director of Public Works and the City's Emergency Management Coordinator.

3. The Director of Public Works, in conjunction with the Streets Superintendent, Police Chief and the City's Emergency Management Coordinator, determines that a state of snow emergency or emergency exists and reports it to the Mayor.

#### 4. CLASSIFICATION OF SNOW EMERGENCIES

- -- 1" to 6" Minor Snow Events storms of this magnitude handled by Public Works and Parks crews (regular plowing). A Snow Emergency would not be declared.
- -- 6" to 12" <u>CLASS 3</u> Snow Emergency Plan is activated using two 12-hour shifts. A snow emergency may be declared. -Snow Emergency Routes, if cleared of cars, do not need snow removal efforts most secondary streets can be plowed open snow removal efforts are generally confined to two snow blower crews plus two loader crews using priority lists on Pages AA-83 and AA-84 minimum equipment rentals would include 1 loader for pushing, 2 loaders for loading plus approximately up to 10 trucks removal efforts around schools will be minimal.
- -- 12" to 18" CLASS 2 Snow Emergency Plan is activated using two 12-hour shifts -some Snow Emergency Routes may need removal (especially Tilghman Street and 15th Street) some narrow streets may require removal efforts with small crews additional rental trucks (up to 25) may be required small rental crews may be needed removal efforts around schools will be stepped up (schools will probably be closed at

#### least two days) - additional salt may be required

- -- over 18" <u>CLASS 1</u> Snow Emergency Plan may be activated prior to the storm-<u>most</u> Snow Emergency Routes will require removal - secondary and narrow streets will require 6-8 small removal crews - help from National Guard may be essential in this area - all-out effort will require minimum rental of 4-6 small crews, two large loaders for pushing, four medium loaders for loading, 30-40 trucks for hauling - removal efforts around schools will be maximum; however, will be delayed several days because school will probably be closed for 3-5 days - additional salt <u>will</u> be required - emergency funding will be essential - Purchasing Agent to be transported to Snow Control Center - National Guard might be contacted.
- After an emergency has been declared, as per Ordinance, Article #527, the Director of Public Works shall notify the Manpower Coordinators who in turn will contact the people indicated on pages AA-9 through AA-10 of the Snow Emergency Plan.

The snow emergency shall be declared between the hours of 7:00 AM to 11:00 PM and shall go into effect **FOUR HOURS AFTER THE DECLARATION**.

- 6. Call-In Procedure Telephone calls announcing the emergency will progress in accordance with Snow Emergency Plan Alert Procedure diagram (See Page AA-8).
- 7. The Manpower Coordinator shall be responsible to contact all Bureau Managers and alert them of the emergency declaration and request their cooperation in call-in of their respective personnel listed on the "Personnel Reassignment Roster".
- 8. The Bureau Managers shall immediately proceed to implement their respective Bureau's snow emergency responsibilities as outlined in the Snow Emergency Plan and coordinate their efforts as required with the overall plan (See pages AA-49).

#### **SNOW EMERGENCY CENTER PERSONNEL & OVERVIEW**

Bureau of Streets Building 1825 Grammes Road

The Snow Emergency Center will be placed in operation by the Bureau of Streets prior to the declaration of an emergency and will be operated by their personnel on a limited basis until the emergency operations are established. All snow-related operations during the emergency shall be directed through the Emergency Center.

When an emergency is declared, personnel will be assigned to the Snow Center using two methods of operation. The two methods and assignments are as follows:

#### METHOD I -- TWO 12-HOUR SHIFTS - WORK SCHEDULE:

POLICE OFFICERS
PURCHASING AGENT

The Snow Emergency Center is equipped with telephones, radios and other equipment necessary for providing control of the total Snow Emergency Operation. The public will have direct contact with the Center by dialing the number 610-437-SNOW (610-437-7669) and will be intercepted by a telephone operator, responsible for the telephone lines.

All communications shall be documented on a complaint card (See Page AA-55) which indicates the complaint, date, name, address and telephone number of the complainant. These cards will be catalogued and dispersed by the Shift Supervisor.

The Center is equipped with three remote radios, one for each of Streets, Parks and Inspections frequency. The radios are located so the operators have direct contact with the telephone operators.

An intercommunications system between the radio room and the conference room is operational along with a public address system covering the entire Snow Emergency Center.

The Bureau of Police shall assign an officer with a portable radio to the Center to provide immediate communication with police personnel in the field.

Upon receiving notice that a snow emergency has been declared, the Bureau of Engineering shall provide the necessary backup engineering and management services for the Department of Public Works as required during the snow emergency and coordinate its efforts in accordance with the requirements of the Snow Emergency Plan.

The Bureau of Engineering will provide the necessary personnel to assist during the snow emergency by providing various services as defined in the Snow Emergency Plan and shall make available, for transportation of personnel, one (1) van and three (3) automobiles.

The Bureau of Engineering shall restrict its normal functions to provide coordination with the snow emergency functions.

#### **BUREAU OF TRAFFIC**

#### TRAFFIC CONTROL SUPERINTENDENT – YEIMY DELGADO

#### SUPERVISOR - WILLIAM DeLONG

Upon receiving notice that a snow emergency has been declared, the Bureau of Traffic shall coordinate its efforts in accordance with the Snow Emergency Plan.

The Bureau of Traffic shall provide whatever manpower is available for the snow emergency effort. They will also provide two (2) vehicles for use as transportation by the Department of Public Works and (1) truck for use as transportation for the sign posting that will be needed.

The Bureau of Traffic shall provide the necessary "NO PARKING" signs and other traffic control devices as required.

The Bureau of Traffic shall restrict its normal functions to provide coordination with the snow emergency functions.

#### **BUREAU OF STREETS**

Immediately upon notification of the declaration of a snow emergency by their respective Bureau Manager, the posting personnel shall proceed to the Bureau of Streets at 1825 Grammes Rd. and report to the supervisor for assignments and instructions.

The sign posting personnel duties are as follows:

- 1. Post "NO PARKING" signs and/or other traffic control devices as required for the removal of the snow.
- 2. Remove "NO PARKING" signs on the street where snow has already been removed.
- 3. On occasion, provide assistance to the snow removal crews by serving as a flagman to provide traffic control in order to protect the operations as well as the motoring public.

Upon receiving notice that a snow emergency has been declared, the Bureau of Streets shall establish operation of the Snow Emergency Center and shall organize its equipment and manpower in accordance with the Snow Emergency Plan.

The Bureau of Streets shall be responsible for snow removal operations except for those assigned to other departments and bureaus.

The Bureau of Streets shall restrict its normal functions to provide coordination with the snow emergency functions.

Upon receiving notice that a snow emergency has been declared, the Bureau of Parks shall coordinate with the Bureau of Streets and provide equipment and manpower as needed and available.

The Bureau shall restrict its normal functions to provide coordination with the snow emergency function.

Upon receiving notice of a snow event or a snow emergency has been declared, the Bureau of Parks shall organize its manpower and equipment in accordance with the snow emergency plan for snow removal operations for those areas of the Bureau's responsibilities.

The Bureau of Parks shall immediately proceed to remove snow from along sidewalks of the following City properties and bridges as per the Bureau's snow control plan:

The Bureau of Parks shall immediately proceed to remove snow from park roadways, parking lots around various buildings and residences, shop lots, etc., as outlined in the Bureau's snow control plan.

The Bureau of Parks shall cooperate and coordinate its efforts with other departments and bureaus of the City relative to the snow emergency operations and, in particular, assist the Bureau of Streets based on conferences with the Manpower Coordinator and Street Superintendent. The Bureau shall restrict its normal functions to provide coordination with the snow emergency functions and immediately proceed to remove snow from streets within District 4 until instructed to assist elsewhere as needed

Upon receiving notice that a snow emergency has been declared, the Bureau of Building Maintenance shall organize its manpower and equipment in accordance with the snow emergency plan for snow plowing and removal operations for those areas of the Bureau's responsibility.

The Bureau of Building Maintenance shall immediately proceed to remove the snow from the following areas:

- 1. City Hall Complex (sidewalk plus streets)
- 2. Bridgeworks Complex (sidewalk plus parking lot)
- 3. 10<sup>th</sup> Street police station (sidewalks & parking deck)
- 4. Assist in plowing alleys in District #1 (East Allentown)
- 5. Assist in plowing at Overlook Park (East Allentown)
- 6. Fire Academy (sidewalks)

The pieces of equipment to be used for plowing are:

Upon receiving notice that a snow emergency has been declared, the Bureau of Recycling and Solid Waste shall coordinate its efforts in accordance with the Snow Emergency Plan. The Bureau of Recycling and Solid Waste shall restrict its normal functions to provide coordination with the snow emergency functions.

The Bureau of Recycling and Solid Waste shall provide whatever manpower and vehicles are available for the snow emergency operations as listed below.

The Bureau Manager shall instruct any personnel who cannot get to the Snow Center on their own to call the Streets Department (610-437-7638) for transportation. All calls shall be made two hours prior to their scheduled shifts.

The Bureau is responsible for plowing as assigned. The four pickups with plows and operators will be supplied:

- 1. #7301 Pickup truck w/plow & Spreader
- 2. #7302 Pickup truck w/plow & Spreader
- 3. #7323 Pickup truck w/plow & Spreader
- 4. #7R004 Pickup truck w/plow & Spreader

The Bureau of Recycling and Solid Waste has the following personnel available to the Streets Bureau as needed:

- (8) Class A CDL drivers
- (1) Class B CDL drivers

As listed above, four additional personnel will be assigned to sign posting and one Clerk shall be assigned to Snow Control Phones.

All personnel will be assigned in order of seniority.

The Bureau Manager, Director and Deputy Director of Public Works shall determine any changes to the citywide trash and recycling collection schedule performed by the city's contractor. Appropriate notification to the public shall be coordinated with the Communications Manager for dissemination.

Upon receiving notice that a snow emergency has been declared, the Municipal Garage shall organize its manpower and equipment to provide maintenance and service to City vehicles and equipment necessary for operations during the snow emergency and in accordance with the Snow Emergency Plan.

The Municipal Garage shall coordinate its efforts closely with the Bureau of Streets to assure that all equipment is properly equipped with chains, snowplows, salt and cinder spreaders, etc., and to provide backup service in the event of equipment breakdown.

The Municipal Garage shall restrict its normal functions to provide coordination with the snow emergency functions.

#### **DEPARTMENT OF POLICE**

#### DEPARTMENT HEAD - CHARLES ROCA

#### ALTERNATE WILL BE ASSIGNED AT TIME OF EMERGENCY

Upon receiving notice that a snow emergency has been declared, the Department of Police shall organize its manpower and equipment in accordance with the Snow Emergency Plan.

The Police Department shall immediately take whatever steps are necessary to enforce Ordinances Articles #527 and #711 relative to parking of vehicles on designated snow routes during a snow emergency and coordinate these activities with the Department of Public Works in the implementation of the snow removal operations.

The Police Department, ten hours after the storm has ended, shall take whatever steps necessary to enforce Ordinance Article #527 for snow being placed in the street and travel lanes.

The Police Department shall also coordinate the Bureau of Traffic in the posting of "No Parking" signs and/or other traffic control devices as required for the snow emergency.

The Police Department shall assign a police officer with a portable radio to the Snow Emergency Center to transmit vital information to other police officers in the field.

The Police Department shall cooperate and coordinate its efforts with other departments and bureaus of the City relative to the snow emergency operations and continue to maintain its normal function.

#### **DEPARTMENT OF FIRE**

#### DEPARTMENT HEAD - FIRE CHIEF EFRAIN AGOSTO

#### ALTERNATE - DEPUTY FIRE CHIEF CHRISTIAN WILLIAMS

Upon receiving notice that a snow emergency has been declared by the Mayor's office, the Fire Department will immediately initiate the following actions:

- 1. Install tire chains on all fire vehicles.
- 2. Install snow plows on three (3) pickup trucks.
- 3. Additional fire hose (1000 linear feet) shall be placed on the pickup trucks for fire service backup.
- 4. Pickup trucks shall be dispatched to clear snow from all fire station ramps.
- 5. Contingent of fire service personnel shall be dispatched to remove snow (shovel) from fire hydrant locations for access.
- 6. The Fire Department shall provide additional manpower (off duty firemen) as required.

The Fire Department shall maintain its normal function and coordinate with the snow emergency operations as may be necessary.

#### ALLENTOWN EMERGENCY MANAGEMENT COORDINATOR

#### EMERGENCY MANAGEMENT COORDINATOR - MATT EHARTH

Upon receiving notice that a snow emergency has been declared by the Mayor's Office, the Emergency Management Coordinator shall make an announcement over all City radio channels that a snow emergency has been declared and also notify the Lehigh County Communications Center via the Hotline that a state of snow emergency exists.

The Emergency Management Coordinator shall maintain their normal function and coordinate with the snow emergency operations as may be necessary.

Once a snow emergency is declared, a CodeRed message will be put out to the Allentown community via that media platform.

#### **PUBLIC RELATIONS**

#### COMMUNICATIONS MANAGER - GENESIS ORTEGA

Upon receiving notice that a snow emergency has been declared, the Public Information Officer shall give notice and advise the general public via radio, television and newspapers of the emergency procedures being taken by the city and inform them of their responsibilities and request their cooperation.

The Public Information Officer shall coordinate their efforts with the Snow Emergency Plan and maintain a close working relationship with the Manpower Coordinator and the activities of the Snow Control Center.

The public should be informed of the following:

- 1. The declaration of an emergency.
- 2. Explanation of no parking requirements on designated routes and requirements as spelled out in Ordinance Article XI in addition to special requirements.
- 3. Request citizen participation in clearing snow from storm sewer drains and fire hydrants.
- 4. Snow clearance from sidewalks as per Ordinance Article XI.
- 5. Request to avoid shoveling snow onto streets.
- 6. Information relative to developments during the snow emergency of the snow emergency operations.
- 7. Any changes to the trash and recycling collection schedule as approved by city officials.

#### MANPOWER COORDINATOR

Immediately upon the declaration of the emergency by the Mayor, and a direct order from the Director of Public Works, the Manpower Coordinators shall initiate the organization of the Snow Emergency Plan by calling all Bureau Managers or alternates of their respective bureaus, directing them to proceed to initiate their bureau's effort outlined in the Snow Emergency Plan and communicate any special instructions which would assist to expedite the emergency effort.

The Manpower Coordinators directly report to the Director of Public Works and shall have total responsibility for the coordination of all personnel and operations during all Snow events and Snow Emergencies and shall assure that operating procedures are in accord with the Snow Emergency Plan.

It is the responsibility of the Manpower Coordinators to keep the time records for the personnel working snow control.

#### RENTAL EQUIPMENT COORDINATOR

Immediately upon notification of the declaration of a Snow Emergency by their respective Bureau Managers, the Rental Equipment Coordinator shall report to the Snow Emergency Center. He will be responsible for coordinating the hiring and scheduling of the various types of equipment needed to assist the City forces in combating the snow storm.

- 1. Contact the contractors listed on the Equipment Rental Roster in order to obtain the pieces of equipment required.

- 3. On a day-to-day basis, for the duration of the emergency, maintain all records, time sheets, etc. in order to compute the cost for each piece of equipment used per shift.
- 4. Handle any and all problems related to breakdowns and reassigning equipment during a particular shift.

#### RENTAL EQUIPMENT MONITORS

Immediately upon notification of the declaration of a Snow Emergency by their respective Bureau Managers, the Rental Equipment Monitor shall report to the Snow Emergency Center. He will be responsible for coordinating the various work assignments needed to assist the City in combating the snow storm.

The monitor will be responsible for the following:

- 1. The Rental Equipment Monitor is to report to the main staging area designated location at the beginning of his or her shift and sign in the equipment which has been assigned for that shift. The monitor shall fill out the log sheet indicating name of contractor/type of equipment (i.e., single axle, 10-wheeler, tri-axle or loader with size bucket). It is important that the monitor identify the unit by either a unit number, license number or some other means of identification. This is needed in order to track the equipment throughout the duration of the operation.
- 2. On a shift-to-shift basis, for the duration of the emergency, maintain all records, time sheets, etc. in order to compute the cost for each piece of equipment used per shift.
- 3. Handle any and all problems related to breakdowns and reassigning of equipment during a particular shift.
- Monitors that help with Flagging during any Snow Emergency operation are required to wear an approved safety vest. Failure to comply will result in disciplinary action.

#### DISTRICT SUPERVISOR

Immediately upon notification of the declaration of an emergency by the Shift Superintendent, the District Supervisor shall initiate the organization of snow fighting equipment and personnel assigned to their respective district and coordinate the snow removal operations as directed by the Shift Superintendent in accordance with the Snow Emergency Plan.

The District Supervisor shall be responsible to assign the snow fighting equipment and personnel to specific areas within their district and monitor the work accomplished in the field to assure that streets are being plowed open to the prescribed width and that the plowing operations are proceeding as shown on the district maps so that no streets are missed.

The District Supervisor shall follow up on all complaints received by checking them out and taking whatever appropriate action is necessary to resolve them.

The District Supervisor shall report immediately, to the Shift Superintendent, any problems which develop with the equipment and manpower and take the necessary steps to remedy the problem as deemed necessary or as directed by the Shift Superintendent.

The District Supervisor shall assure that the Snow Emergency Center is constantly updated as to the status of the operations in their district and keep appropriate records so that actions can be backed up should problems arise at a later date.

The District Supervisor, at the end of the shift, shall report to the on-coming supervisor as to work completed, status of equipment and whatever other information may be helpful toward continuing smooth operations.

#### **DISTRICT SUPERVISOR**

#### EMERGENCY OPERATIONS CENTER OPERATORS

Immediately upon notification of the declaration of a snow emergency by their respective Bureau Manager, the EOC Operators shall proceed to the Snow Emergency Center and report to the Shift Supervisor for assignment and instructions.

The EOC Operators shall be directly responsible to the Public Works Administrative Manager. Duties shall consist of receiving and dispatching messages and documenting necessary information on a complaint record card (see Page AA-55) and inputting necessary information into the Lucity Work Order system. He/she shall maintain direct contact and coordination with the Telephone Operators and assist in the expedition of complaints and perform related duties as directed by the Shift Supervisor.

#### ARTICLE XI Snow Routes: Snow Removal

#### § 615-33. Definitions. [Amended 1-7-1970 by Ord. No. 11784]

The following words, when used in this article shall, unless the context clearly indicates otherwise, mean or include as follows:

CITY — The City of Allentown.

PERSON — Any natural person, firm, copartnership, association or corporation.

STREET — Every way or place of whatever nature, within the City, open to the use of the public as a matter of right, for purpose of vehicular travel.

VEHICLE — Any device in, upon or by which any person or property is or may be transported or drawn upon a public street.

# § 615-34. Declaration of snow emergency. [Amended 12-1-1970 by Ord. No. 11838; 10-6-1994 by Ord. No. 13283]

- A. In the event weather conditions make it necessary for motor vehicle traffic to be expedited and parking on City streets be prohibited or restricted for snow plowing and other purposes, the Mayor or the Mayor's designated representative shall declare a snow emergency. The declaration of a snow emergency may be made on any of the seven days of the week at anytime between the hours of 7:00 a.m. and 11:00 p.m. Such declaration shall not go into effect until four hours after it has been announced. Once in effect, a prohibition under this section shall remain in effect until terminated by announcement of the Mayor or the Mayor's representative, except that any street area which has become clear of snow and ice from curb to median line for the length of the entire block shall be automatically excluded therefrom. While the prohibition is in effect, no person shall park or allow to remain parked any vehicle on any portion of a snow emergency route.
- B. However, nothing in this section shall be construed to permit parking at any time or place where it is forbidden by any other provision of law.

# § 615-35. Snow emergency routes. [Amended 3-20-1997 by Ord. No. 13557; 12-26-2011 by Ord. No. 14961]

# § 615-36. Prohibited parking. [Amended 1-3-1973 by Ord. No. 11984; 10-6-1994 by Ord. No. 13283]

In the event any street is scheduled by the Mayor, or the Mayor's designated representative, for snow removal, it shall be unlawful for any person to park a vehicle at or failure to remove a vehicle from any place along such street:

 Four hours following such posting on all established four-hour-or-less parking meter zones on streets;

Four hours following such posting on all established limited parking zones on streets; and

C. Six hours following such posting on all other streets.

## § 615-37. Removal of vehicles. [Amended 1-7-1970 by Ord. No. 11784; 10-6-1994 by Ord. No. 13283; 1-7-1999 by Ord. No. 13727]

Any vehicle parked in violation of the provisions of this article may be removed by any member of the Police Bureau, their designee, or a designated Allentown Parking Authority personnel. Any vehicle removed may be towed to and placed at any area designated by the Mayor or his duly designated representative for impounding of vehicles. All costs for removal, towing, storage or parking of any vehicle removed under the provisions of this section shall be paid by the owner of the vehicle and the vehicle shall remain impounded until all costs are paid.

## § 615-38. Snow removal. [Amended 1-7-1970 by Ord. No. 11784; 10-6-1994 by Ord. No. 13283]

- A. No person shall remove snow or ice from private property and put, place, deposit or cause to be put, placed or deposited snow or ice so removed upon the right-of-way of any street.
- B. No person shall remove or cause to be removed snow or ice from any sidewalk or footway and put, place, deposit or cause to be put, placed or deposited snow or ice so removed upon that portion of the street normally used for the travel of vehicles.
- C. This section shall not be in force and effect in areas where curbside parking is prohibited or there is no available private property upon which to put, place or deposit snow or ice so removed.

#### § 615-39. Violations and penalties for snow removal provisions. [Amended 6-6-1985 by Ord. No. 12658; 8-5-1987 by Ord. No. 12784]

- A. Any police officer or other duly authorized Parking Authority employee shall place on motor vehicles/conveyances parked in violation of the provisions of § 615-34, Declaration of snow emergency, and § 615-36, Prohibited parking, a notice of said violation. [Amended 12-1-1993 by Ord. No. 13227; 10-6-1994 by Ord. No. 13283]
  - Each such owner or operator may, within 10 days of the time when such notice was attached to his motor vehicle/conveyance, pay as a penalty and in full satisfaction of each violation the sum of \$35. [Amended 4-9-2001 by Ord. No. 13901]
  - (2) Each such owner or operator may, from the 11th to the 20th day of the time when such notice was attached to his motor vehicle/conveyance, pay as a penalty and in full consideration of each violation the sum of \$50.
  - (3) Failure of the owner or operator to make payment after 20 days shall make the owner or operator subject to a penalty not to exceed \$100. [Amended 4-9-2001 by Ord. No. 13901; 5-3-2023 by Ord. No. 15898]
- B. Whoever violates § 615-38A, Snow removal, shall, upon conviction thereof, pay a fine or penalty of not less than \$25 nor more than \$300 and costs. [Amended 10-6-1994 by Ord.



#### **Snow Removal in Alleys**

Snow removal in alleys, when an emergency has been declared, has become a major concern for the City.

Due to the development of many residential living units in these areas it is imperative that we approach removal efforts in an aggressive, and progressive, manner in order to address these concerns. To achieve this, we have divided the City into two zones, which would establish 5 work areas; two (2) in Zone A – East of American Parkway N.E, and three (3) in Zone B – West of American Parkway N.E

In approaching this effort, the individual assigned to a work crew (or group of work crews) is directed to follow the order of removal by street, <u>and direction</u>, as outlined below, unless otherwise directed:

## 1. Scope

This SOP describes Best Management Practices (BMPs) adopted by the City for road salt (chloride-based deicers), abrasives and other solid and liquid chemicals that may be used in combination with mechanical removal methods (such as plowing) to minimize accidents during the winter months. Activities described in the SOP are performed in coordination with the Snow Emergency Plan in Reference 11.4.

#### 2. Introduction

Snow operations can become sources of pollution as a result of storage practices and overapplication of deicing materials if proper measures are not implemented.

#### 3. Definitions

Abrasives/antiskid materials: Materials which serve to provide a temporary friction layer on the road surface.

Anti- icing: Proactive method of preventing snow and ice from bonding to pavement.

De-Icing: Application of a deicing material to the roadway after a snowfall event has occurred and

the snow has bonded to the roadway.

Pretreating: Mixing a non-caking liquid into a stockpile of salt before it is applied.

Prewetting: The process of coating a solid deicer with a liquid before it is spread on a roadway.

#### 4. Responsibilities

- Bureau of Streets is responsible for snow removal and deicing operations in the City's road right-of-way and City parking lots as assigned in the Snow Emergency Plan.
- Parks and Recreation Department performs snow removal and deicing operations at Parks' facilities and as assigned in the Snow Emergency Plan.
- Bureau of Recycling & Solid Waste performs snow removal and deicing operations at its facilities and as assigned in the Snow Emergency Plan.
- Building Maintenance and other City staff may engage in minor treatment of sidewalks and building entrances using bagged or boxed deicing materials and as assigned in the Snow Emergency Plan.

#### 5. Best Management Practices Incorporated into Daily Procedures

## 5.1. Salt, Deicer and Abrasives Storage

Improper storage of winter maintenance materials can impact stormwater runoff during all seasons when inventories are maintained.

- Cover for salt, other deicers and anti-icers and mixtures thereof. Salt and other chemical deicers are stored in a covered, permanent structure or container at all times, unless actively loading. Containment structures should be permanent in their construction and made of materials that are not subject to salt corrosion.
- Temporary storage of salt and other chemical deicers outside designated permanent structures is not recommended. Temporary storage piles must be covered with impermeable, adequately secured tarpaulin at all times when not actively used.
- Impervious Bottom. Salt and other chemical deicers will only be stored on an impervious surface such as a concrete slab or an asphalt. The use of a tarp or other material as an impervious bottom is not adequate, unless specifically designed and certified to meet regulatory requirements as described in reference 11.1.
- <u>Liquid chemicals</u> need to be stored in labeled tanks. Proper secondary containment for tanks and associated auxiliary equipment (pumps, valves, dispensers) should be provided.
- Management of Run-on and Run-off. Salt, antiskid, and other deicer materials and mixes must be stored away from storm drain inlets and other conveyance structures. Storage structures must provide adequate barriers to prevent run-on into the storage pile and to minimize erosion. Run-off from salt and other chemical deicer piles should be eliminated, contained, recycled or disposed into the sanitary sewer or any other approved method. Diverted and captured run-off containing salt material can be returned to the storage pile or managed as salt brine.
- Antiskid materials that are not mixed with salt or chemical deicers can be stored
  outside enclosures but methods to reduce runoff contamination and pile erosion
  should be implemented. Such methods include use of tarps, silt fences, berms and
  other methods of containment to prevent entrance of contaminated runoff into storm
  drains.

#### 5.2. Deicer Preparation, Transfer and Loading

- Various solid deicing mixes of salt and antiskid are prepared on site, inside a covered building, utilizing front loader equipment.
- Best management practices during the mixing process include minimization of spilled materials outside covered area and reducing of dropping heights to minimize dusting.
- In house preparation of liquid deicing solutions occurs inside the maintenance garage in dedicated equipment and the resulting solution is pumped into the storage tanks outside.
- Anti-icing solution is purchased and is delivered into the dedicated tank that is provided with secondary containment.
- Loading de-icing materials in dispensing trucks occurs in the area adjacent to storage. Applied good management practices include avoidance of overfilling loader and truck, and minimization of drop heights to prevent spillage. Care should always be taken not to overfill any of the containers utilized.

## 5.3. Abrasives, Deicer, Anti-icer, Use and Application

- Alternative methods to reduction of deicers and abrasives include snow removal methods such as mechanical means to remove snow, plowing, shoveling, or blowing should be used as much as possible. Snow fences can help reduction of blowing snow.
- Abrasives increase friction thus salt/antiskid mix is used for improved safety during freezing rain when salt alone is washed away quickly.
- <u>Deicing Material.</u> Prior to each winter season, the City will assess prior years
  maintenance and use of deicing materials, and to the extent practical, will select
  the materials and mix that has the least impact on water quality while still effectively
  meeting public safety needs.
- Anti-icing. Liquid anti-icing materials can effectively reduce the amount of deicing material necessary for a storm event. Anti-icing applications should be conducted per manufacturer's recommendations.
- <u>Pre-wetting</u> chemicals accelerate the brine making process, which improves the melting action of the material and contributes to a reduction in their use.
- The City maintains proper inventories of all winter maintenance materials to minimize and eliminate outside storage or overflow from the designated storage buildings and containers.
- <u>Equipment Calibration</u>. All equipment will be calibrated in accordance with the
  manufacturer's instructions and the specified applications rates for the various
  material being applied. Calibration will include plowing speed and applicable
  spreader settings. The manufacturer's instructions are maintained at the Streets
  Department facility and referenced prior to each winter storm event.
- Application Rate. The City will use the lowest application rate that will effectively treat surfaces to meet safety needs as recommended by various references including annual PennDOT Local Technical Assistance Program (LTAP) training.

- The City maintains winter snow and ice control procedures that outline levels of service, application rates and plowing frequency for various areas including awareness of salt vulnerable locations.
- <u>The City utilizes various weather</u> services to forecast storms and select the most efficient combination of maintenance procedures according to conditions.
- The spreader will be turned off while loading and any time the vehicle is not moving forward.
- Trucks loaded with de-icing material will be parked under cover whenever possible.

#### 5.4. Deicer Cleanup and Spill Control

- <u>Loading areas</u> will be swept frequently to prevent salt or sand build-up and run-off and recycle swept material inside storage facility. At a minimum, loading areas should be inspected and swept following each storm event or other period when handling occurs. Spilled deicing materials will be collected and reused or disposed of properly.
- <u>Street Sweeping.</u> The City conducts routine street sweeping beginning in spring to clean up debris and other materials that collect during winter months, including salt, sand, and other deicers.
- <u>Small Applications.</u> To the extent practical, small amounts of salt, sand, and deicing
  materials applied to sidewalks or building entrances by City staff will be swept up
  and recycled/disposed of properly when weather conditions allow.
- Vehicle Washing at Streets and Garage municipal facility. Spreading and other
  equipment used during deicing operations and materials preparation will be washed
  at the designated wash station draining to sanitary sewer.
- <u>Do not dump left over road salt or brine</u> after finished with a run, clean out truck using dry methods prior to washing the truck. <u>Recovered solid abrasives/antiskid from street sweepings</u> during spring campaign can be recycled immediately inside the salt/antiskid building, or if free of salt, it can be used as road subbase on City property or roads, filling for potholes and other fill.
- Accidental, large spillage of salt solution from the single wall tanks utilized for storage can be addressed by facility personnel through implementation of methods for containment within facility stormwater structures. The closest stormwater inlets should be blocked promptly with adequate storm drain covers. Use plugs in pipes leading outside the facility. Remove the inlet covers and vacuum out structures. Surfaces can be power washed inside the inlets. Collected salt solution can be recycled/reused after concentration adjustments.

#### 5.5. Snow Storage, Dump Areas

- See Appendix 1: Snow Dump Site Locations with Stormwater Infrastructure. These locations include Jordan Park and Kline's Island Wastewater Treatment Plant.
- Consideration must be given to the disposal of snow removed from roadways. This snow may contain higher concentrations of roadway salts, sediment, other pollutants and litter. The City has designated snow dumping areas in its Snow Emergency Plan.

Considerations for selection of snow dumping areas include:

- Areas where abrasives and other debris will be contained (depressed areas) after snowmelt for later removal.
- Areas away from drainage systems and/or private or public drinking water well supplies (more than 100 feet due to the possible presence of road salt).
- Take preventive measures to avoid impact or blockage of stormwater infrastructure with debris, sediment and ice utilizing appropriate stormwater BMP including filer inlets, silt fences, temporary/permanent construction fences etc.
- Remove all debris and sediment from storm drains, ditches and basins at the end of winter season.
  - Do not dump accumulated snow:
- Into waterways, wetlands, or on top of storm drains.
- On stream or riverbanks that slope toward the water, where abrasives and debris can get into the watercourse.
- In stormwater management/green infrastructure BMP areas.

#### 6. Communications

Emphasize communication and coordination for municipal departments and operations and with county and state agencies according to the Snow Emergency Plan.

#### 7. Safety

Adopt general safety procedures according to department requirements.

## 8. Training

- All personnel who perform winter maintenance activities related to road, parking lot, right of way and City properties must be trained per this SOP with a frequency determined by department manager.
- Training material for this SOP and Best Management Practices for snow operations is developed in house or may be provided by a vendor or outside agent such as LTAP.

#### 9. Records

Records are maintained by various City departments involved with winter maintenance activities and include used materials and amounts, inventories, materials Safety Data Sheets (SDS), materials quality certificates, application rates, applications frequencies, inventory of maintenance locations and areas, weather records, equipment calibration records, sweeping records for roads, right of way, parking lots, stormwater inlet cleaning, personnel training, etc. The records are maintained in various formats including paper located in various files, electronic versions saved on the N drive, or Lucity work order system.

#### 10. Documentation

Documents including this SOP, SDS, Snow Emergency Plan and regulations are maintained in various formats and are reviewed at least annually.


# **DRIVEWAYS**

- 1. The City endeavors to clear as much snow and ice from the road as possible to expedite traffic and make travel safer. When City snow plow trucks clear roads, they'll make multiple passes up and down the roads over an extended period of time. While snow is not intentionally pushed into residential driveways, unfortunately it's unavoidable and snow will accumulate.
- 2. The City recommends that residents wait until the snow plows finish clearing the streets before shoveling driveway entrances.

## **SIDEWALKS**

3. Residents are responsible for clearing snow and ice from sidewalks along their property. It's also recommended to wait until the snow plows finish, because snow cleared from the roads can push into sidewalks.

# **Preventing Snow Shovel Injuries**

## Dos:

- · Dress in layers
- Stay hydrated
- Pre-treat with salt or ice-melt before it starts snowing
- · Shovel only fresh powdery snow

- · Push the snow rather than lift it
- Use an ergonomically-designed snow shovel

# Don'ts:

- · Shovel after eating a heavy meal
- Smoke cigarettes before, during and directly after shoveling
- Rush, instead take frequent, 15-minute breaks
- Lift the heavy snow shovel with your back
- Throw the snow over your shoulder
- Leave a snow blower running while unattended
